TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entrants are only open to Australian residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex- spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step- parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step- brother, step-sister or 1st cousin.
4. The Promotion Period begins at 6:00 am on 12 August 2026 and closes at 1:00pm on 23 August 2026 or until prizes are exhausted, whichever occurs first.
5. To be eligible, individuals must complete the following steps during the Promotional Period:
 - a. Make one or more purchases of \$50 that are Eligible Transactions.
An "Eligible Transaction" is a transaction made by an entrant who makes a purchase at a Participating Retailer during the Promotion Period, but does not include: payment for services (e.g. electricity, gas, telephone), registrations (e.g. motor vehicle registration), premiums (e.g. insurance and health fund premiums), rates, 'click and collect" (online purchases), subscriptions, medical and cosmetic services, TAB, liquor and cigarette purchases, deposits or payments to financial institutions or any similar payments (including payments made to Australia Post, newsagency and lotteries purchases), each of which will not qualify as an Eligible Transaction. Entrants may provide more than one receipt to make up the total sum of \$50 required to receive the Promotion Prize, if this is exercised the purchases on the receipts will need to have been made on the same day within the Promotion Period.
 - b. Complete all the fields on the form and submit to the centre database; and
 - c. Show your confirmation screen to the Promotion Staff along with your receipt/s.
 - d. All receipts (physical or electronic) must be presented for validation at the time of voucher collection. Physical receipts may be stamped or marked, and electronic receipts may have relevant transaction details recorded, to prevent multiple claims. Receipts that have already been used for this promotion will not be accepted.

- e. If eligible, you can collect your voucher between the hours of 10:00am and 1:00pm from the Special Promotions Desk, located near Woolworths.
- 6. Each individual may receive no more than three (3) vouchers per day.
- 7. More than 1 receipt can be submitted to claim the Promotion Prize, on the condition that the receipts have the same date of purchase. Furthermore, the receipts will only qualify if the date of purchase is within the Promotion Period.
- 8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the discretion of the Promoter. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 9. Incomplete or indecipherable entries will be deemed invalid.
- 10. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 11. The Promoter's decision is final, and no correspondence will be entered into.
- 12. Promotion Prize or "prize": \$10 Dinner For Less Voucher to participating takeaway retailers (see website for details). Voucher is only redeemable at Seven Hills Plaza during trading hours and will expire at midnight on Sunday 30 August 2026.
- 13. Any ancillary costs associated with redeeming the Promotion Prize are not included. Any unused balance of the Promotion Prize will not be awarded as cash. Redemption of the Promotion Prize is subject to any terms and conditions of the issuer including those specified on the Promotion Prize.
- 14. If any Promotion Prize (or part of any Promotion Prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the Promotion Prize (or that part of the Promotion Prize) with a prize of the equal value and/or specification, subject to any written directions from a regulatory authority.

Nothing in these Terms and Conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non- Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by an entrant or (f) use of/taking of a prize.

The Promoter collects personal information ("PI") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, as required, to Australian regulatory authorities.
