## SEVEN HILLS PLAZA Fresh Food Frenzy Promotion

## **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entrants are only open to Australian residents aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, exspouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
- 4. The Promotion Period begins at 10:00 am on Saturday 13 December 2025 and closes at 1:00 pm on Sunday 14 December 2025 or when the prize allocation is exhausted, whichever occurs first.
- 5. To be eligible, individuals must complete the following steps during the Promotional Period:
  - a. Complete all the fields on the form and submit to the centre database; and
  - b. Make one purchase of \$50 per day that are Eligible Transactions.   - c. Show the confirmation screen and receipt to the Promotion Host outside 7Hills Chicken Corner during the hours of 10am 1.00pm on Saturday 13 December and Sunday 14 December to be eligible to spin the wheel for a chance to win a prize.
  - d. The entrant will spin a prize wheel divided into eight segments, numbered 1 through 8. There are eight corresponding boxes, also numbered 1 through 8. The number the wheel lands on determines the prize: the entrant wins the prize inside the box with the matching number. Prizes are randomly placed in the boxes before each turn.

- 10 x \$50 pre-packed chicken trays from 7Hills Chicken Corner, 5 x \$100 vouchers to spend at Healthy Bee, 200 x Free Coffee Cards). The total prize pool is valued at \$4.500.
- 10. The Promoter's decision is final, and no correspondence will be entered into.

responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by an entrant or (f) use of/taking of a prize.
